

Changes or increases below this rate shall be notified to you in writing at least 30 (thirty) days prior to the change in writing or through permanent data registry or by call to your registered phone number. You have right to stop using such product and service within 15 (fifteen) days following this notification. In case you exercise this right, additional fee shall not be charged as of the effective date of such increase. In case you do not exercise this right, the increase of the fee/charge will apply. Our Bank has the right to suspend related product or services in case you exercise this right within the said period.

COLLECTION METHOD:

According to the products and services, the collection is made in cash or by deduction from account or based on customer's request by debiting the relevant amount into the credit card or collecting from the overdraft deposit account.

Any and all the information other than those stated above are given in the Agreement. A copy of this form annexed to the Retail Customer Agreement, is hereby delivered to you in order for you to carefully overview this form and request detailed information from our Bank on the matters not clean.
