(3) You are allowed to withdraw any sum up to TRY 1.500 in addition to the daily limit of TRY 10.000 BITT is included.

(4) EFT charges are fixed and per EFT transaction made through the Branches, CEPTETEB Internet Branch, CEPTETEB Mobile Branch, ATM and TEB Phone Branch; and BITT is excluded. EFT fee is not collected for CEPTETEB Account and CEPTETEB Marifetli Account.

(5) Remittance fees are fixed and per transaction made through the Branches, CEPTETEB Internet Branch, CEPTETEB Mobile Branch, ATM and TEB Phone Branch; and BITT is excluded. Remittance fee is not collected from CEPTETEB Account and CEPTETEB Marifetli Account.

(6) In addition, Collected from transactions performed with Mobile and Online Branch CEPTETEB accounts.

The fee notifications regarding the non-continuous transactions, and instant transactions and services such as invoices collection shall be given to yourselves through the related channel before the collection and the transactions are carried out and related collections and transactions shall be accomplished based on your approval. In such cases the obligations of the notification stated above of our Bank shall not apply since the fee notification is given explicitly and before the related collection or transaction has been made. #### VALIDITY TERMS OF THE FEES AND NOTIFICATIONS ON CHANGES

Fees, charges and commissions defined in this form shall be increased within a calendar year by the annual consumer price index rate to be declared by the Turkish Statistics Institutions as of the end of the previous year. Changes or increases below this rate shall be notified to you in writing at least 30 (thirty) days prior to the change in writing or through permanent data registry or by call to your registered phone number. You have right to stop using such product and service within 15 (fifteen) days following this notification. In case you exercise this right, additional fee shall not be charged as of the effective date of such increase. In case you do not exercise this right, the increase of the fee/charge will apply. Our Bank has the right to suspend related product or services in case you exercise this right within the said period. The Bank shall obtain approval of the Customer for fee, expense, and commission changes, which require increase above the rate specified in the legislation within one calendar year.

#### COLLECTION METHOD:

According to the products and services, the collection is made in cash or by deduction from account or based on customer's request by debiting the relevant amount into the credit card or collecting from the overdraft deposit account.

Any and all the information other than those stated above are given in the Agreement. A copy of this form annexed to the Retail Customer Agreement, is hereby delivered to you in order for you to carefully overview this form and request detailed information from our Bank on the matters not clean.
